Membership figures were displayed, with current membership at 470 having increased over the past years. Attention was drawn to the 2023 accounts and Trustees' Report, which was available to view or download from the Trust's website. It was reported that income from house lettings continued to rise annually.</p>

Byddai Robert Townsend, a oedd wedi bod yn ymddiriedolwr ers blynnyddoedd lawer, yn sefyll i lawr fel Ymddiriedolwr am flwyddyn o fis Mai 2024 i ganolbwytio ar ei rôl fel archdeacon Meirionnydd.</p> <p>Esboniodd llywodraethu'r ymddiriedolaeth, h.y. mae'r prif gyngor yn cyfarfod 4 gwaith y flwyddyn gydag is-bwyllgorau sy'n cynnwys:</p> <ul style="list-style-type: none"> • Y Pwyllgor Iechyd a Diogelwch • Pwyllgor Gweithredol • Pwyllgor Gwyddonol • Pwyllgor Ysbrydolrwydd • Pwyllgor Adeiladau • Pwyllgor Diwylliannol <p>Roedd y Pwyllgor Diwylliannol wedi'i ffurfio yn 2023 a byddai'n cael ei gadeirio gan yr Ymddiriedolwr newydd, Alun Llwyd.</p> <p>Mynegwyd diolchgarwch i'r caplaniaid a oedd yn gwirfoddoli ar yr ynys bob wythnos o'r tymor. Roedd caplaniaid o ystod lawn o enwadau Cristnogol, gyda nifer y rhai yn ddwyieithog yn cynyddu bob blwyddyn.</p>	<p>Menna Jones had been successful with several grant applications in the two years of her role, and examples of the grants received were listed, and included:</p> <ul style="list-style-type: none"> • £246,000 Heritage Lottery Fund, "Etifeddiaeth Enlli" for promoting the island's heritage with numerous projects. • £4,000 from Pantyfedwen for Capel Enlli repairs. Further grants towards the chapel refurbishment, which would be celebrating 150 years in 2025, were being sought. • Gwynedd Council, Area of Outstanding Natural Beauty, £30,000. • UK Government Levelling Up Fund via Gwynedd Council - £14,000 towards artists in residence programme. • Architectural Heritage Fund: £40,000 towards Storws renovations. <p>Thanks were expressed to the individuals and businesses that had been involved with the restoration of the Storws in 2023.</p> <p>The Trust now had a good team of Trustees with four new trustees appointed in 2024. Robert Townsend, who had been a trustee for many years, would be standing down as Trustee from for a year from May 2024 to focus on role as arch deacon of Meirionnydd.</p> <p>Governance of the trust explained, i.e. the main council met 4 times a year with sub committees consisting of:</p> <ul style="list-style-type: none"> • Health and Safety Committee • Executive Committee • Scientific Committee • Spirituality Committee • Buildings Committee • Cultural Committee <p>The Cultural Committee had been formed in 2023 and would be chaired by new Trustee, Alun Llwyd.</p> <p>Gratitude was expressed to the chaplains who volunteered on the island every week of the season. Chaplains were from a full range of Christian denominations, with the number of those being bilingual rising each year.</p> <p>The Trust was pleased to be continuing its relationship with Gareth Roberts the island farmer, with farming methods in harmony with the island National Nature Reserve status.</p>

Work was ongoing on celebrating and promoting this status.</p> <p>In August 2023, the Bardsey Island Trust was present at the National Eisteddfod in Boduan.
